

#### 25th session of the United Nations Commission on Crime Prevention and Criminal Justice

23rd -27th May 2016, Vienna



Opening Session

The 25th session of the United Nations Commission on Crime Prevention and Criminal Justice (CCPCJ) was held in Vienna from 23rd – 27th May 2016. Approximately 1000 delegates from the governments, NGOs and academic community attended the conference.

UNODC Executive Director, Yury Fedotov made an opening speech., "Justice and the rule of law can be build resilient institutions that support the 2030 Development Agenda, particularly for the

Goal 16, together with the Doha Declaration, they can provide a roadmap for confronting links among poverty, security, crime, and corruption."

Under this framework, the commission formally acknowledge crime issues, crime prevention and criminal justice responding to the Goal 16 of the SDGs, but practically, little was done in result. Interestingly, the conference was combined with lots of interesting side-events and exhibits with the collaborations of different parties, providing a democratic forum for many NGOs and governments, UN institutes and academia to inform the international crime prevention and criminal justice community. Dr. Zhang Lei and Dr. Shang Haowen from Beijing Normal University talks about the antiterrorism cooperation situation in China. They have presented the Legislative Developments from 1980s to 2016.

In 1980s: Administrative Laws, such as the Administration Law on Exit and Entry of Foreigners (1985) and the Postal Law (1986) was established

In 1997: The Criminal Law of People's Republic of China was established



In 2001: The 3rd Amendment to the Criminal Law of the PRC

In 2011: The 8th Amendment to the Criminal Law of the PRC, the NPC Standing Committee Resolution and Amended Criminal Procedure Law

In 2015: The  $9^{th}$  Amendment to the Criminal Law of the PRC and the Counter-Terrorism Law of the PRC

China have carried out bilateral anti-terrorism mechanism with Russia, Pakistan, India, Turkey, Thailand, Singapore, Malaysia, Indonesia, Vietnam, United States and so on.

They have first, concluded bilateral treaties, second, carry out anti-terrorism drills, third, improve the exchange of anti-terrorism intelligence, fourth, strengthen cooperation on border management, prevent the transnational flow of terrorists.

The Prevention of Terrorism with Social governance measures:

- 1. To stick to the priority of national equality all the time, allocate resources reasonably, pay special attention to the regional economic development, and narrow the gap between rich and poor;
- 2. To strengthen the communication between different ethnic groups, advocate the mutual respect between different cultures, and balance of interests between different ethnic groups

With key points to solve the ethnic problems:

- a) Nation Concept adhere to the national equality and national unity policy
- b) Political civilization adhere to the policy of regional national antonomy
- c) Material civilization speed up the economic development of ethnic minority areas, promote the prosperity of all nationalities in policy
- d) Spiritual civilization adhere to the development of minority education policy of cultural undertakings
- e) Training cadres and all kinds of talents from among ethnic minorities
- 3. To go deep among the masses, understand the real thoughts and needs of people, solve problems and contradictions timely.
