Although your presence is not mandatory and **will not affect in any way** the consideration of your application, you have an option to send no more than two representatives to be present in the Committee. Unfortunately, as the Committee will have approximately 350 new and deferred applications to consider, we cannot determine the exact date at which your application will be reviewed during the session.

Information pertinent to your application during its review will be posted in the **NGO Response System**, accessible from the NGO Branch website at www.un.org/ecosoc/ngo.

The Committee on NGOs will meet from 10:00 a.m. to 1:00 p.m. and 3:00 p.m. to 6:00 p.m. each day during the session.

Please be advised that an official pass is necessary to enter the United Nations premises. For security reasons, attending representatives are requested to bring valid photo identification (e.g., passport, driver's license, etc.), in order to be issued the temporary grounds pass to United Nations premises. These passes will be issued from 9:00 a.m. to 11:00 a.m. and 2:30 p.m. to 3:30 p.m. at our office, located at:
